Other Discussion:

- Discussion was held regarding the continued lack of lighting in the Dollar General Parking area and entrance into the business. He then sent an email and said a work order was in the system to repair the outdoor lighting of the parking lot and entrance. Discussion was also held regarding talking with Adams Electric and Ameren to see about the possibility of putting a street light along the highway with a light projecting across to the entrance.

- Discussion was also held regarding a speed limit sign on 1100 North (near the Unity Multiplex). A resident of a property at the Multiplex has complained and asked for the issue to be looked into. The ordinances that are involved with be reviewed and a recommendation for any change will be made at the January 2023 meeting.

- Discussion was held regarding moving the January meeting to the Mendon Diner and Tap and to change the start time for this one meeting to 6:15. The change of time and place will be posted on the next Agenda, the Village Web Site and the Mendon Dispatch.
